Students should provide their ACCA registration number, upon enrolment. To be eligible to attend the Globaltraining ACCA courses and granted access to the Moodle Platform, students must complete the online enrolment form, pay the 50% deposit and ensure that fees from previous term(s) are fully settled.

Terms of Payment
