

## Cyprus Business Taxation: Overview and Updates

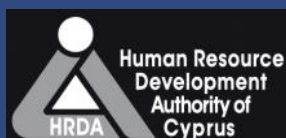
Andreas is one of the most experienced tutors in Cyprus concerning taxation and has been a valuable asset for Globaltraining for over 20 years.
